SHAPING THE FUTURE OF GREEN FINANCE AND INSURANCE

The **Finance Innovation Festival – Insurance and Investment Opportunities for Nature-Based Transformations** brings together policymakers, insurers, investors, researchers, cities, and civil society to explore how **finance and risk-transfer mechanisms** can accelerate the large-scale deployment of **Nature-based Solutions (NbS)**.

Over three days, the Festival provides a structured space to connect policy ambition with market innovation, focusing on **two critical pillars**:



Insurance as a tool for risk transfer and resilience



Investment strategies to mobilise capital for nature-positive outcomes

FROM INSIGHT TO ACTION: DIVERSE SESSION FORMATS

The Festival combines high-level policy dialogue with hands-on, solution-oriented sessions. **Strategic plenaries and moderated panels** will convene relevant stakeholders to examine emerging regulatory frameworks, market standards, and public-private funding instruments.

These discussions are complemented by **interactive sessions, world café tables, and peer-to-peer exchanges** that allow participants to engage directly with real-world examples, tools, and methodologies, with a dedicated space for collaborative problem-solving and cross-sector learning.

Topics addressed during the conference will include:

- EU & private **financing frameworks** for nature-positive action
- Innovative insurance, risk-transfer, and parametric **resilience models**
- **Data, valuation & cost-benefit tools** to support NbS business cases
- **Investment readiness, markets & capital mobilisation** for NbS
- **Policy, urban action & citizen engagement** to boost impact

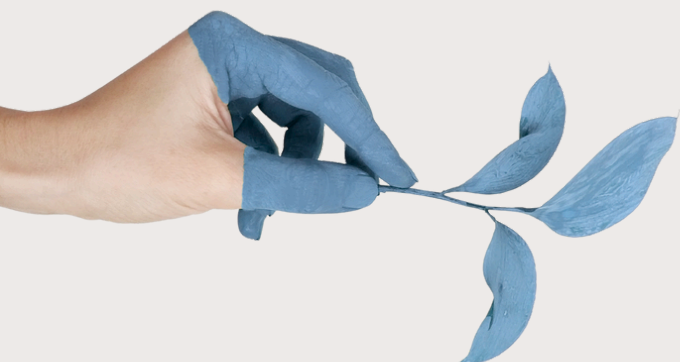

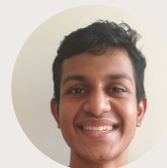

Spotlight on Naturethon: *Citizens growing nature-based futures*

The **Naturethon initiative**, part of the NATURANCE project, brought together individuals interested in local adaptation to climate-related risks, fostering purposeful dialogue and the exchange of perspectives. Through these conversations, participants contributed to reshaping how Nature-based Solutions (NbS) are understood, embraced, and brought to life within their communities.

The second edition concluded in December 2026, with three proposals awarded for their innovation, feasibility, and environmental and social impact. The awarded proposals will be featured during the Finance Innovation Festival in the Seeds of Change: Citizens & Cities session.

NATURETHON AWARDED PROPOSALS



Explore Sustainable Financing Strategies to Scale Up NbS for Cool Milan (Milan)

The **COOL MILAN** team presented a strong, data-driven analysis of urban heat risks in Milan. Built around the 3-30-300 approach, the project proposes well-designed NbS with each intervention clearly described and illustrated through “before and after” narratives. It stands out for its innovative mix of existing and new financing instruments, strong stakeholder engagement, and a coherent, ambitious vision.

Johannesburg’s Biodiversity Restoration (Johannesburg)

The **Green City Champions** proposed a community-led NbS approach to address biodiversity loss, climate risks, and social challenges in Johannesburg. Combining urban greening, habitat restoration, and community farming, the project stands out for its strong stakeholder engagement, scalable business model, and innovative mix of public, private, and grassroots financing.



C.A.R.E. – Community Action for River Ecosystems (Treviso)

The **RisorGivers** team addressed the degradation of spring-water ecosystems in Treviso through well-documented Nature-based Solutions, including ecological corridors and urban greening. Engaging over 1,500 citizens and stakeholders, the initiative combines strong community action with a hybrid financing model, offering a solid, feasible, and impact-oriented approach to biodiversity restoration.

Bresch, Professor for Weather and Climate Risks at ETH Zürich/MeteoSwiss since 2016. 2000-2016, roles at Swiss Re included Head Business Development, Global Head Sustainability, Head Atmospheric Perils Group and Chief modeler for natural catastrophe risk assessment. 1998-1999 Research Associate, MIT, Cambridge, USA. Member of the Swiss UNFCCC delegation 2009-2012 and 2015, member of the Private Sector Advisory Group of the UN Green Climate Fund (GCF), 2014-2016. PhD in physics from ETH Zurich, Switzerland. His research focuses on the impacts of weather and climate on socio-economic systems. Combining numerical modelling of weather and climate risks with the engagement of decision makers and end-users, his research aims to explore ways to strengthen resilience based on a shared understanding of their weather and climate susceptibility. Such an integrated view along the chain of impacts also opens new perspectives to the treatment of uncertainty in decision-making. **(Day 1 - S2)**

Her work is part of the Future FRM Tech project, focusing on developing new technical and Nature-based Solutions for flood risk management. In her work, she develops a new flood risk model to calculate object-based flood risk. She uses this model to assess the effect of several flood risk adaptation measures. She has a strong interest in combining hydrological modelling and social sciences to develop the best flood risk management strategies. **(Day2 - S6)**

Getting to Brussels

Brussels is served by two airports, the Brussels International Airport and the Brussels South Charleroi Airport. From both of them you can easily take the train or the bus to get to Brussels city centre.

Plane

Brussels International Airport

From Brussels Airport there is a fast, direct train connection to the main Brussels railway stations (Brussels North, Brussels Central and Brussels South). There is a **direct train** every 15 minutes in both directions which takes to the centre of Brussels in just 17 minutes.

The standard ticket price for travel between the airport and the Brussels Zone is €9,30 per trip (return trip €18,60), which includes the airport fee. Please note that if you already have an SNCB ticket, you will have to pay the airport fee separately. Another option to get from the Brussels Airport to Brussels is the [bus line 12](#). Brussels South Charleroi Airport

This airport is located 60 km from Brussels and the possible connections are by bus (city shuttle) or by taking a combination of bus and train. **Brussels City Shuttle** is operated by the Flibco company and will take you from the airport directly to Brussels South station (or the other way around) with no stops in between.

The average price is 16,60€ and a single ticket is valid one ride at any time in the day selected. There is no possibility to reserve seats and “first-come, first-served” approach is applied, reason why we suggest to buy tickets online rather than on site at the counter. A bus leaves at agreed time or earlier if full. The average time of the journey is 45 minutes. You can buy the tickets [here](#).

An alternative way to reach Brussels city centre is to take the **TEC A bus** to the Charleroi Gare Centrale (every 30 minutes) and then a train to Brussels Central station (twice an hour). This ticket is called Bus TEC Charleroi Airport Ticket and you can find more information [here](#).

Bus

Several **international bus companies** provide fast transit between major European cities and stop in Brussels, either as a final destination or as an intermediate stop on routes to and from cities such as Amsterdam, Berlin, London, and Paris. Have a look at [Eurolines](#) and [Flixbus](#).

Car

This solution is **not recommended**. The entire Brussels-Capital Region is a low emission zone, this means that the most polluting vehicles are not allowed to drive here.



Train

In Brussels there are **five main railway stations**, which are interconnected:

- **South Station**

 - Paris: Thalys,
 - France: TGV high-speed rail service
- **North Station**
 - Amsterdam
- **Luxembourg Station**
 - Luxembourg
- **Schuman Station**
 - European institutions

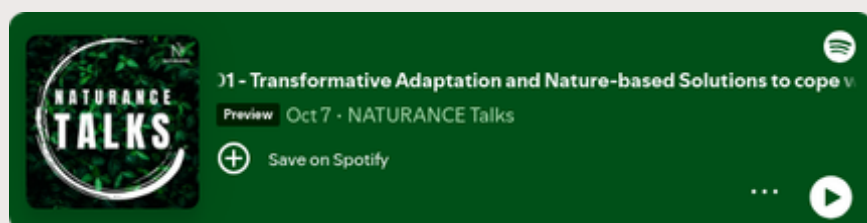
